Delivering our services in this way also means a better deal for staff who work hard to provide services to our residents and customers. We're

putting in place organisations that should offer longer-term job security." Our priority would be a seamless transition to maintain current service levels. I am remaining in my role. Message from Kevin Melling, Head of Environmental Protection and Enhancement



Welcome to this newsletter for employees potentially affected by the formation of the new WOC. The proposed scope of the company has been broadened and now includes Waste, Fleet, and parts of the Streetscape and Sustainable Environment Team. These new elements include grounds maintenance, mechanical sweeping, street cleansing, open space development and technical functions including play areas, trees and drainage.

The remaining teams in the service which are currently considered to be out of scope are Bereavement Services, the streetscape team in Congleton devolving to the Town Council, public rights of way, countryside ranger service and markets and toilets (which have not already transferred to town and/or parish councils.) We will continue to talk to these staff separately.

We have been working closely with the trade unions on these proposals and I am very happy with how the programme is progressing so far. We have asked focus groups of staff, members and residents for their views on the name and logo for the new company and I am happy that we have come to a decision. The name of the company will be 'Ansa' which means 'loop' in Latin, and reflects how the company has a mission to keep up a continuous service. The next stage is to design some logos for signage, uniforms and vehicles – we will be asking your views again over the coming months on the design.

A report is going to Cabinet on 15 October to consider:

- Forming this wholly owned company;
- Investing in vehicles; and
- Improving depots across the Borough.
